

**CONTRACT FOR PROVISION OF ENGLISH LANGUAGE COURSES 2010
Group**

This contract is made between

Eckersley Oxford, 14 Friars Entry, OX1 2BZ, Oxford, UK (hereinafter called "The School")

and

ITC Deganutti, via Diaz 60, 33100, Udine, Italy (hereinafter called "ITC Deganutti group")

1. The school undertakes:

a) to accept the following groups of students and accompanying leader:

12 students + 2 accompanying teacher from 28 November to 5 December 2010 for a 1-week General English course of 21 hours per week.

b) to arrange accommodation from **Sunday 28 November to Sunday 5 December** for the students with families in shared rooms. Two meals (breakfast and supper) will be provided by the families from Mondays to Fridays, and lunch additionally on Saturday and Sunday if the student is present at lunchtime.

To arrange homestay accommodation for Ms. Luisa Tubaro and Ms. Paola Antonutti in a shared room.

The school will supply family addresses and telephone numbers not later than one week before the arrival date.

c) to arrange transfers from/to the airport as requested and as offered on quotation given.

d) to arrange a to organise a full-day guided excursion to London by public transport with the Oxford Tube. Half-day guided walking tour of London.

e) to organise social activities for the students.

f) to ensure, to the best of the School's ability, the welfare of the students attending our courses and to provide them with any assistance that they may need.

2. ITC Deganutti group undertakes:

- a) to agree with the school as early as possible the dates and times of arrival and departure of students.
- b) to pay GBP 4,870 by 28th October 2010 at the latest. If we do not receive the payment in time, the school will be forced to cancel the group arrangement.
- c) to inform the school immediately of any cancellation, additions or changes in the students' program.
- d) to ensure that students have sufficient information before they come to England about the school and the programme which they are going to attend, and also about life and conditions in England.
- e) in case of unsociable arrival/departure hours, we will charge the Italian school/students for extra taxi transfer to/from the coach meeting point. This will vary from GBP 10 to GBP 15 per family.
